- Check that all staff and volunteers are the right people to work with children and young people, and give them training so they know how to keep kids safe.

## **Appendix A: Words and What They Mean**

Child or Young Person	A person under the age of 18.	
Child Safe Standards	Eleven mandatory standards in Victoria to help organisations keep children and young people safe from harm.	
Child Safety Compliance Officer	A designated Council Officer responsible for leading and coordinating child safety actions.	
Child Safe Code of Conduct	A set of rules outlining expected behaviours of staff, volunteers, and contractors with and around children and young people.	
Council Leaders	A team called Executive Management Team. It includes the CEO and a group of directors. The CEO is at the top of the council team that looks after the city. The CEO works with directors who each take care of different things like parks, roads, and libraries.	
Risk Assessment	A process to identify and reduce potential risks to children and young people in physical or online environments.	
WWCC (Working with Children Check)	A background check required for people working or volunteering with children or young people.	
Reporting Process	The steps to follow when raising concerns or incidents involving child safety.	
Empowerment	Supporting children and young people to have a voice and participate in decisions that affect them.	
Culturally Safe Environment	A setting where all children, including Aboriginal and Torres Strait Islander children and young people, feel respected and safe.	

### **Appendix B: How to Report a Safety Concern**

## **Child Safety Reporting Flowchart**



#### Anyone can report

Anyone can report- child, young person, parent, carer, Councillor, Council Worker or others in the community



#### Any child safety concern, complaint or incident

For example

- Allegations of abuse or misconduct by a staff member, a volunteer or another individual associated with Council
- Disclosures of abuse or harm made by a child
- The conduct of a child at Council
- The inadequate handling of a prior concern
- General concerns about the safety of a group of children or activity

#### Call 000 without delay if a child or young person is in immediate danger

#### The Child Safety Compliance Officer, manager, supervisor will:

- Offer support to the child, the parents, the person who reports and the accused staff member or volunteer.
- Initiate internal processes to ensure the safety of the child, clarify the nature of the complaint and commence disciplinary process (if required).
- Decide, in accordance with legal requirements and duty of care, whether the matter should/must be reported to the police, Child Protection and/or CCYP and make report as soon as possible if required.



**Investigation**: outcome decided; relevant staff, volunteers, parents and child notified of outcome of investigation, policies, procedures updated where necessary.

# **Appendix D: Child Safety Rules in Victoria**

Standard	Description
1. Culturally safe environments	Children and young people from all cultures, including Aboriginal children and young people, must feel safe, respected, and proud of who they are.
2. Child safety embedded in leadership	People in charge must always make child safety a top priority in everything they do.
3. Child empowerment and participation	Children and young people should know their rights and be given chances to speak up and make decisions about things that affect them.
4. Child and family involvement in decisions	Families and communities must be included and involved in keeping children and young people safe and well.
5. Equity and inclusion	All children and young people must be treated with kindness and respect, no matter what their background, ability, or identity.
6. People who work with children are safe and caring	Everyone who works with kids has been checked to make sure they are kind and trustworthy. They also get help and training, so they know how to keep children and young people safe and happy.
7. Child-focused complaints processes	Children and young people must be provided the opportunity to speak up if something is wrong. There must be easy, safe ways to make a complaint or ask for help.
8 Staff and volunteers equipped with knowledge, skills, and awareness	Adults who work or volunteer with children or young people must be trained to know how to keep kids safe and speak up if something isn't right.
9. Physical and online environments promote safety	Buildings, programs, and websites must be made safe, so children and young people are protected from harm and feel secure.
10. Review and continuous improvement	Organisations must check their safety plans regularly and make them better whenever they can.
11. Policies and procedures support child safety	There must be clear and up-to-date safety rules that help adults make the right choices and keep kids and young people safe.
